**Copy of current Negative Coggins MUST accompany entry form and check.**

**Entry fee:** Horse Trial \$80.00 per entry. Double entries accepted (same rider/different horses).  
Combined Test \$60.00 per entry. Double entries accepted (same rider/same horses). Make checks payable to WCPC.  
This is a schooling show to introduce beginning riders and horses to eventing. Classes will be divided if entries warrant.

**Refunds:** Before closing date: less \$15.00 office fee. After closing date: no refund. Withdrawals must be made in writing and received or emailed by 5:00 PM on closing date. Competition cancellation – no refund. Horse/rider substitutions are permitted.

**Awards:** Prizes for 1<sup>st</sup> to 3<sup>rd</sup> and Ribbons to 8<sup>th</sup> Place

**Ride times:** Times will be posted on the web on October 30 @ [walnutcreek.ponyclub.org](http://walnutcreek.ponyclub.org)

**Attire:** Approved helmets and appropriate boot with heel required. Medical armbands required for jumping phases. Jackets, Safety Vests and braiding optional.

**Food** and drinks on grounds. Dogs **MUST** be leashed.

**Directions: From I-75/I-71 north of Cincinnati:** Take I-275 West and follow it South to the Kilby Rd. Exit (#21).

➔ Turn right onto Kilby Rd. Go 1 mile, then turn right on Rt. 50 (at light), 1½ mile west to left on Lawrenceburg Rd (at light), ½ mile to right at 'T' (still Lawrenceburg Rd), ½ mile to left on Mt. Nebo Rd. Go 1 1/8 mile to farm entrance on left.

**From Indiana:** Take I-74 East to I-275 South to Kilby Rd. exit (#21) and follow previous directions (from ➔ above).

**From KY:** Take I-275 West past the airport, to first exit after crossing the Ohio River (Exit #16, Lawrenceburg, IN). Turn right on to Rt. 50, go east ¾ miles to right on Lawrenceburg Rd (at light), ½ mile to right at "T" (still Lawrenceburg Rd) ½ mile to left on Mt. Nebo Rd. Go 1 1/8 mile to farm entrance on left.
